- ii. Trail Maintenance Work Day October 22nd from 9am noon. Volunteers will meet at Gary's place.
- iii. Tree trimming and Removal along Midland Motion and unanimous vote approval was made that a max of \$6,540.00 to hire arborist Rod Davis at Branching Out Tree and Landscape Service for tree removal and stump grinding off Midland. Final cost will depend on the number of cedar trees removed. Tia will also work with neighbor Dan Foster, a landscape architect, to purchase landscaping to replace trees. \$2,000.00 was also unanimously approved for this project. Family Tree Nursery has ½ price Fall pricing, thus the perfect timing of this purchase. Bushes may also be included, if approved budget allows, to replace two bushes at the ROH entrance at Lind at the same time.
- iv. Mailbox pad replacement A motion was made by Tia for a \$7,500.00 budget for mailbox concrete pads replacement. This was seconded by Carol, with unanimous approval given to have Dave Thurman begin work tearing out and replacing 8 concrete pads. We have to pay for lumber which is an extra cost. \$5,250.00 for the 5' deep concrete pad, from 4" depth used previously, and remainder going towards the lumber cost. Work will begin on the most needed work first as weather permits. Tia will contact neighbors when projects will occur in their area. She will identify the closest neighbor to each mailbox repair to request willingness to share their water and electricity needed to complete the project.
