#### **NEIGHBORHOOD WATCH PROGRAM**

On April 19<sup>th</sup>, the Neighborhood Watch Program (NWP) met to continue organizing and hear Mayor Meyers and Officer Loridon from the Shawnee Police Department speak. Here are some of the topics covered.

- Dogs are to always be under control which means that they should be on a leash or confined. If a dog is well trained and can walk with you, it is okay for the dog to be off leash. However, dogs can get distracted. It is acceptable to use appropriate force to protect yourself or your dog if you are attacked (see above). Mace or a club is acceptable to use as a protective measure.
- 2. Forty eight hours is the maximum that a car can be parked before it is considered to be abandoned.
- 3. If you feel you must have a gun for protection, a 12 gauge shotgun is best.
- 4. Solicitors must have a license issued by the city. If a solicitor comes to your door, ask to see his license.

- 5. On the issue of speeding, adding speed bumps and/or reducing speed limits are not part of the city's plan. Police cruisers and speed traps are part of the city's plan and will continue to be used in Red Oak Hills. Make a personal resolution to only go 20 MPH within our community. Every time a new family with small children moves into ROH, the Board gets emails from parents fearing that their children are in danger due to excessive speeds.
- 6. Please do your best to park in your driveway and stay 100 feet from intersections. The hills and curves in ROH can reduce visibility; do not make it worse by creating new blind spots with your parked car.
- 7. We live in a relatively safe area. However, with easy and quick access to I-435, a child on the way to the school bus could be easy prey. "Watching out for each other is the best method to keep safe" according to Officer Loridon. If you see someone who appears to be out of place, call 911.
- 8. Skateboarders are not illegal, but if they are on your street and you want them to leave, call 911. When a police cruiser shows up, they generally leave.
- 9. When you see a street light out or any other city service that is in need of repair, go to <u>www.cityofshawnee.org</u>, click on Contact Us and then click on Citizen's Service Request and describe the problem. We have done it many times and it is 100% effective.
- 10. Our ward had the highest percent of voters who voted in Johnson County. 20% of us voted compared to the county average of 12%.

## **TIDY TOWN IS COMING SOON**

Tidy Town is the name of Shawnee's large item pick up service and for residents who live west of Pflumm it will take place on **Saturday**, **May 5th**.

Your trash hauler is responsible for picking up these items. This service is included in your basic rate. Contact your hauler for specific instructions that they might have and for a list of items that they will pick up.

Remember, do not place hazardous materials such as car batteries, paints, solvents, or liquid waste out for collection. Call Johnson County Department of Health and Environment for disposal of these items at 715-6900.

Haulers will pick up all items that they accept that look like they are out for pick up. Please be sure to remove items that you want to keep like basketball goals, containers you intend on keeping, etc. from the curb during your collection day.

**Special Reminder**: If you are a Deffenbaugh customer, you will need to set one of your Deffenbaugh carts at the end of the curb so they know to pick up your items. If you do not do this, your items will not be collected

### **DOG ALERT**

A dog being walked by its owner was attacked by another dog on Clairborne Court on Saturday, April 14th. ## **ROH RECIPE OF THE MONTH**

#### **Bacon Appetizer Crescents**



prep time 20 min total time 35 min makes 16 servings

1 pkg. (8 oz.) PHILADELPHIA Cream Cheese, softened 8 slices OSCAR MAYER Bacon, cooked, crumbled 1/3 cup KRAFT Grated Parmesan Cheese 1/4 cup finely chopped onions 2 Tbsp. chopped fresh parsley

## 1 Tbsp. milk

2 cans (8 oz. each) refrigerated crescent dinner rolls

Heat oven to 375°F. Mix all ingredients except crescent dough.

Separate each can of dough into 8 triangles; cut each triangle lengthwise in half. Spread each dough triangle with 1 generous tsp. cream cheese mixture; roll up, starting at short side of triangle. Place, point-sides down, on baking sheet. Bake 12 to 15 min. or until golden brown. Serve warm.
