## **NEW RECYCLING CODES EFFECTIVE JAN 1st**

As of Jan 1, 2011 the City of Shawnee will implement the new city codes relating to trash and recycling. These are NOT the rules of Deffenbaugh or any other hauler. These are city ordinances. Here are some of the key provisions:

Everyone will be required to have a recycling cart. There are no exceptions. Residents with disabilities (steep driveways, for example) can get help from Deffenbaugh. If you have not ordered a recycle cart, now is a good time to do it. HOA members can call Gary Turner at 268-4513. Non members should call 631-3300 for Deffenbaugh Customer Service.

In order to encourage recycling, excess trash will be subject to a PAYT (pay as you throw) fee. The more trash that you have the more it will cost. Your cart must be securely closed. Bags sticking out the top of the cart will not be picked up unless a sticker is attached. The HOA will have stickers for sale at a cost of \$1.20 each.

### ROH RECIPE OF THE MONTH

#### PARMESAN AND THYME CRACKERS

½ Ib (1 stick) unsalted butter, at room temperature
4 oz freshly grated Parmesan cheese (about 1 cup)
1 tsp minced fresh thyme leaves
½ tsp kosher salt
½ tsp freshly ground black pepper
1 ¼ cups all purpose flour

In the bowl of an electric mixer fitted with a paddle attachment, cream the butter for one minute. With the mixer on low speed, add the Parmesan, thyme, salt and pepper and combine. With the mixer still on low, add the flour and combine until the mixture is in large crumbles, about 1 minute. If the dough is too dry, add 1 tsp water.

Dump the dough onto a floured board, press it into a ball, and roll into a 9 inch log. Wrap in plastic and refrigerate for at least 30 minutes or for up to 4days.

Meanwhile, preheat the oven to 350 degrees. Cut the log into 3/8 to  $\frac{1}{4}$  inch thick rounds with a small sharp knife and place them on a sheet pan lined with parchment paper. Bake for 18-22 minutes, until very lightly browned. Rotate the pan once during baking. Cool and serve at room temperature.
